**ORDER AND INJUNCTION**

**THE COURT HEREBY FINDS:**

1. This court has jurisdiction over the parties and the subject matter of this action.
2. Plaintiff, Te-Ta-Ma Foundation – Family of URI, Inc. (the “Foundation”), owns Trademark Registration No. 1,496,724, which is incontestable, valid, and enforceable. It includes the term “Church of the Creator,” which is not generic.
3. Defendant, World Church of the Creator (the “World Church”), a voluntary association, has infringed the above trademark registration by selling, offering for sale, distributing and advertising books, pamphlets, newsletters, on TV and radio, and on the Internet under the names and marks, and by otherwise using in its operations the names and marks, “World Church of the Creator,” in violation of the Lanham Act, 15 U.S.C. § 1051 *et seq.*, and Illinois common law.

**THE COURT, THEREFORE, ORDERS:**

4. That defendant World Church and its members, officers, directors, predecessors, successors, assigns, agents, employees, representatives, attorneys and all other persons acting for, with, by, or under authority from it, or in concert or participating with it, and others having knowledge of this Order, are permanently enjoined and restrained from directly or indirectly:

a) using the name and mark CHURCH OF THE CREATOR or any colorable facsimile thereof, including specifically WORLD CHURCH OF THE CREATOR, WCOTC, COTC, or the words "Church" and "Creator(s)" together in the same name or mark, in connection with its proselytizing, business, products, services or Web sites, and/or from providing a link to Plaintiff's Web site, [www.churchofthecreator.org](http://www.churchofthecreator.org); or

b) using the domain names "churchofthecreator.com" or "wcotc.com" or any other domain name which would violate paragraph (a) above; including in metatags or other invisible text; or

c) doing any other act or thing calculated or likely to create or induce the belief that defendant's operations or publications and/or Internet web page(s) are in any way affiliated, connected, associated, sponsored, licensed or authorized by or with the Foundation.

5. IT IS FURTHER ORDERED that the World Church shall immediately transfer custody and control of the domain names at issue here, namely, "churchofthecreator.com" and "wcotc.com," to the Foundation and shall assign these domain names to the Foundation. This transfer may be accomplished by the parties under the rules and procedures of Network Solutions, Inc., or such other methods of transfer as may be reasonable.

6. IT IS FURTHER ORDERED that the World Church and its members, officers, directors, predecessors, successors, assigns, agents, employees, representatives, attorneys, and all other persons acting for, with, by, or under authority from it, or in concert or participating with it, and others having knowledge of this Order, in accordance with 15 U.S.C. § 1118, will deliver up for destruction (or, where feasible, removal or obliteration of any infringing mark from) all

letterhead, labels, signs, flags, banners, clothing or tee-shirts, prints, packages, books, products, digital images or Web Site copy, in any media or form, in their possession, custody or control, which would violate paragraphs 4(a)-(c), and that all plates, molds, matrices, computer media, disks, computer memory, or other media containing such information be delivered up for destruction or deleted, with evidence and proof of such deletion to be provided in verified form to the Court and to the Foundation. Items delivered for destruction should be delivered to: Davis & Campbell, 401 Main Street, Suite 1600, Peoria, Illinois, or another location agreed to by counsel between the Foundation and the World Church.

7. IT IS FURTHER ORDERED that the World Church will immediately notify in writing, or by electronic mail (e-mail), all publishers of directories, lists, banner advertisements or search engines in which the World Church appears under a name protected under Paragraph 4(a) or (b), to delete all such references to the World Church for or under this name or this domain name from such directories or listings, or from their cache memories, and/or from all future directories in which the name might otherwise appear in reference to the World Church


8. IT IS FURTHER ORDERED that the World Church shall within seven (7) days notify in writing, and by electronic mail (e-mail), all of its members of this Order, and shall deliver a copy of this Order to them.

9. IT IS FURTHER ORDERED that, to the extent not accomplished by this Order, the assignment of the domain names "churchofthecreator.com" and "wcotc.com," shall be held in trust for the benefit of the Foundation, and assigned under the principles of law and equity to the Foundation.

10. The Foundation may be entitled to an award of its damages, to be determined by further proceedings of this Court.

11. IT IS FINALLY ORDERED that the World Church be required, in accordance with 15 U.S.C. §1116, and other laws, to file with the Court and serve on the Foundation within 30 days a report in writing, under oath, setting forth in detail the manner and form in which the World Church has complied with the terms of this court.
