A INFORMATION:

R Deputy Ford was on routine patrol when he came behind a vehicle
R that had an expired license plate. Deputy Ford initiated a traffic
A stop.

T CONTACT DRIVER: ANGELA W [REDACTED]

V Deputy Ford approached the drivers side of the vehicle and made
E contact with the driver. Deputy Ford asked for Operator's License,
registration, and proof of insurance. Angela stated she had no
driver's license, as she was restricted, and stated she was going
to manpower to check on employment, as she couldn't get through on
the phone. Angela could not produce proof of insurance or a valid
registration. Deputy Ford asked Angela to step from the vehicle at
this time. At this time, Deputy Ford was joined on the scene by
Trooper Sysko, MSP.

INTERVIEW SUSPECT/DRIVER:

Deputy Ford could smell an odor of intoxicants coming from Angela
as she spoke. Deputy Ford asked Angela if she had been drinking
this day and she stated she had. Deputy Ford asked what and when
her last drink was. Angela stated she had a couple of shots of
"Captain Morgan" about 15 minutes prior to the stop. Deputy Ford
ran field sobriety tests and Angela passed them. At this time
Deputy Ford asked consent to search Angela's vehicle. Deputy Ford
read Angela her consent search rights, before Trooper Sysko, and
Angela consented to the search.

VEHICLE SEARCH:

Deputy Ford searched the vehicle while Trooper Sysko stood by.
Deputy Ford located under the passenger side, a pint size bottle of
"Captain Morgan" rum, with approximately 2" consumed.

ADDITIONAL INFORMATION:

Deputy Ford asked Angela if she had written proof of destination
and hours, and other documents pertaining to her restriction.
Angela stated she did not. Deputy Ford also advised that Angela
needed her license with her when she drove. Deputy Ford asked
Angela if she was going to manpower looking for a job. Angela
stated she was. Deputy Ford asked Angela if she expected to get a
job going to a placement company with liquor on her breath. Angela
had no answer. Deputy Ford asked Angela if she was actually just
driving around having a drink because she couldn't at home. Again,
Angela had no answer.

ARREST:

Angela was placed under arrest for driver, transporting open
intoxicants in a motor vehicle, and for violation of restricted
drivers license. Angela was handcuffed and placed in the rear of
unit 417, and transported to the Emmet County Jail.
