9-7-03 Tx from Cpl. Rodwell re suspicious death. Briefed re information known to that point.

9-7-03 Respond to scene on Brutus Road. Brief with Rodwell. Request Fire Dept bring out some flood lights. Advised Rodwell to call out Sumpter to do tech work.

9-7-03 Interview with Adam Paskle, on road way, along side 420, inside 420. Adam was not under arrest, just background questions and basic even information. Adam admitted to a verbal agreement with victim. Adam denies hitting or striking victim. Adam admits to being in his car, and the car running, car was put into reverse. Adam denies the car ever moved. Adam denies running over victim.

9-7-03 Observe scene compare Adam's version of events with evidence at scene.

9-7-03 Brief with Trooper Janicki re his knowledge of the persons involved. Request Trooper Janicki attempt to locate Angela W [REDACTED] witness and sister of the victim.

9-7-03 Additional conversations with Adam Paskle near unit 420. Provided Adam with two cigarettes and a shirt to wear. Adam admits to giving victim two and one third Klonopine. Adam states they were drinking vodka. Adam again denies running over Tom.

9-7-03 Brief with Janicki, he was able to locate Angela. 10:00 p.m. Speak with Angela near the troop car. Angela was a witness to the entire event. Says the two were fighting over some stupid remark Tara made about flirting with some other guys. Angela denies that Adam fought back, stating that Tom her brother, the victim was the aggressor. Tom got a knife and started cutting on him self. Angela stated that she and Adam were trying to leave when Tom collapsed behind the car. Angela admits the car was running and placed in reverse, but stated the car never moved.

9-7-03 Sumpter speaking with Paskle. Brief with Sumpter re information from Angela. Transport Angela to Station M119 for further statement.

9-8-03 0015 hrs. Speak with Angela W [REDACTED] at Station —119. Same statement, that the car did not move. Written statement done by Angela.

9-8-03 Drop Angela off at NMH ER to be evaluated. Angela has mental health issues and volunteered to go in for an evaluation.

9-8-03 Back to scene later in the morning. Officers just finishing up doing tech work. Waited till day light. Conway on scene to move the vehicle.

9-8-03 Search warrant for Adams blood, and clothing. Bankey will serve.

9-9-03 Brief with Dr. Hawkins re autopsy. Dr. Start at Spectrum did the exam. No fatal injury found. No blunt force trauma like would be found if hit or run over by a car.

Most likely an OD. Fluid in the lungs was really heavy. Tox report will take a few weeks. Per Hawkins he is comfortable saying its an OD.

9-9-03 Advise Sheriff Wallin of Autopsy results. Per Sheriff Wallin contact local Media who have been calling.

9-9-03 Advised family of autopsy results.

9-9-03 Open pending autopsy results.

9-9-03 Speak with witness who was walking by during the time of the fight. Patti Blunke [REDACTED] She and her sister were walking by on Brutus Road that night and heard the agreement.

9-9-03 Open pending official autopsy and tox report.
