SUMMARY:

I overheard a dispatch to the Emmet County Sheriff Department of an Attempted Suicide. I arrived on scene and assisted at the scene.

SCENE:

I was dispatched to the scene at 8:22 PM after I heard 2416 requesting assistance. I arrived on scene at 8:31 PM. The ambulance was at Brutus Rd and US 31 when I turned onto Brutus Rd. The address was E Brutus Rd. The driveway was dirt and was south of Brutus Rd. There was a trailer on the property with 3 vehicles parked in the driveway. The suspect, ADAM PASKLE, was west of the driveway with Dep Copeland. The victims wife, T WIERTALLA, was talking to Dep Erickson.

CRIME SCENE TECHNICIAN/PHOTOGRAPHS:

I assisted Dep Erickson photographing the scene. I used an MSP Digital camera and took 16 photographs. I gave the disk to D/Sgt Johnston while at the scene. I then did the first part of the photograph log for Dep Erickson while he took photographs.

EVIDENCE OBSERVED AT SCENE:

I observed the blood on the Propane tank, blood on the ground by the tank, blood on the door of Paskle's car, bracelet in the driveway, broken watch at the tank and smudge marks on Paskle's car.

Information at the scene was that Angela [REDACTED] had left the scene. W [REDACTED] is on Circuit Court Probation. Information was received that W [REDACTED] was at her Uncle Jack and Aunt Phyllis's house on North Ayre Rd. I was requested by D/Sgt Johnston to pick up W [REDACTED] and bring her to the scene.

INTERVIEW WITNESS:

I picked up W [REDACTED] at 9:53 PM from [REDACTED] and transporter her back to the scene.

When W [REDACTED] first sat in the car I asked her how she was doing. She said okay and then asked about her brother. I did not know the status at the time and informed her I did not know. I then asked her about the fight. W [REDACTED] stated there was no fight. She told me Thomas cut himself and Adam was struggling to get the knife away. Angela stated she went to the car and sat there. Thomas came to the window. Angela stated she was just doing stuff and Adam never moved the car. Angela stated Adam never put the car in reverse and the car never moved. The next thing she knew Adam looked in the mirror and stated Thomas was laying behind the vehicle. Only the two things were asked to Angela and she was then interviewed by D/Sgt Johnston.


