INFORMATION:

On 04/13/05 at approximately 1421 hrs I (Deputy Erickson) was assisting Lt. Keiser at Conway Towing. After clearing the assist to Keiser, I was told that there were a few complaints pending. One of the complainant's involved retail fraud from Glen's North.

CONTACT WITNESS: Terry Bonar (manager)

I was unable to make contact with Bonar on the 13th due to the fact that he had left work prior to my response. I was advised that Bonar would be working on 04/15/05. While attempting to make contact with Bonar another employee of Glen's was able to tell me that after witnessing the event, Bonar walked across to McDonald's where he saw the suspect (who was an employee of McDonald's) working in the drive threw area. I then asked the female if it would be possible to get a video tape of the event. I was told that the incident was recorded and that a copy of the tape would be available on the 14th. I was also told that the time on the tape was off by approximately one hour (the incident took place at 13:40-13:45 and the time on the camera was 12:40-12:45). While at Glen's I was given a copy of the display journal which had the date and time that the suspect purchased one of the items. The time was 13:47 and the item was a travel pack of NODOZ.

Due to having some time off I asked Deputy Barrett to assist me with following up on this complaint. When I arrived back to work on 04/22/05, I received a message from Barrett. He advised me that he had obtained a written statement from Bonar and a copy of the video tape.

On 04/22/05, I stopped at Glen's to speak with Bonar. Bonar described the suspect as having blond, shoulder length hair that was slightly wavy at the ends. Bonar stated that he did not want to guess on her height or weight and added that after watching her walk through the Glen's lot and to the McDonald's he walked into the McDoanld's and saw the female working in the drive threw area.

I then asked Bonar to explain how he knew that the suspect had taken one of the items without paying. Bonar stated that he saw the female place something into her pocket he then saw her walk around and pick up a second item. Bonar stated that he then saw that the suspect paid for a travel pack of NODOZ. Bonar stated that when he followed the suspect outside the store he saw her opening a bottle near the garbage. Bonar stated that when the suspect walked away from the garbage he found the travel pack of NODOZ and the card board package from a bottle of NODOZ. (these were given to me on 04/13/05).

Bonar added that the same female came into the store on Friday and did purchase some more NODOZ.

FOLLOWUP:

On 04/22/05 I went to McDonalds and made contact with Manager Brenda Campbell and Manager Lee Socolovitch. I explained the reason for being there and Campbell stated that she had been working on the 13th. Campbell stated that she remembered an employee asking to check out and go to Glen's. Campbell stated that because the employee stated she was sick she let her. After giving the description to Campbell she stated that the only person working the drive threw that day that matched the description and that went to Geln's was Angela Washington.

INTERVIEW:

On 04/22/05, I called the phone number that I had for Washing but was not able to make contact. On 0427/05, I again called the number for Washing and the female stated that she was. When I explained the reason that I had called her Angela first denied taking the

NODOZ. Angela stated that she did remember going to Glen's to buy NODOZ but that she never would have stolen any. Angela added that she was on probation and had way too much on the line to do anything like that.

I then advised Angela that the events were caught on video tape and a witness picked the packages out of the garbage just outside of Glen's. I again asked Angela if she remembered taking a bottle of NODOZ. Angela stated that she did not remember this and stated that if it was on tape and I had the packages she must have done it. I asked Angela what she meant by this. Angela stated that she did not remember taking the item but must have. Angela stated that she had worked seven days straight and was sick. I then told Angela that her statement did not make any sense due to the fact that both packages were in the garbage together and she paid for one of them.

Angela then stated that she did remember but it was not until she got outside that she realized the package was in her pocket. I asked Angela why she just didn't go back into the store and pay for the three dollar item. Angela stated that she did not think anyone would believe her because she was on probation and a convicted felon. Angela then asked what she would need to do to make the situation right. I suggested that she needed to take responsibility for her actions ad advised her to talk with her probation officer about the matter. I also advised her that I would be seeking a warrant for the retail fraud.

ITEMS STOLEN:

One bottle of NODOZ. \$2.99.

EVIDENCE:

- A) Video surveillance.
- B) Two empty card board packages of NODOZ. One was a travel pack (4 caplets) and the other was from a bottle (16 caplets). The bottle was inside the box. The top was off the bottle and the bottle was empty.
- * The video was placed into evidence. The packages were secured and saved for latent print examination.

FOLLOWUP:

I called Glen's and talked with the Manager, Mark Zink. I asked Zink if they were interested in pressing charges. Zink stated that it is their policy to press charges on any retail fraud complaints.

STATUS:

The complaint can be closed. A warrant request is being submitted on Angela Warrant for retail fraud. The original report will remain on file at the Emmet County Sheriff's Department. A copy will be turned over to Probation Officer Hopkins.
