## CRIMINAL SEXUAL ASSAULT (FORCED/WITH INJURY)

### INFORMATION:

I was investigating a possible parental kidnapping and while interviewing ANGELA W [REDACTED], she disclosed several domestic violence and sexual assaults, where her boyfriend, JOEL DUFRESNE beat her and sexually assaulted her, forcing penis in her mouth and anus and forcing objects into her anus. The sexual assaults started after she was severely beaten in Cadillac by DUFRESNE, on June 25, 2005 and continued until he left on February 14, 2006.

ANGELA briefly disclosed some forced sexual assaults during a interview on 02/14/06.

About two weeks ago while she was in the shower, JOEL came in shoved his dick in her throat she couldn't breathe and she told him, she couldn't breathe. ANGELA was gagging and trying to pull away. When she did this he threatened her to hit her. JOEL kept doing it over and over again until he was done, and came in her mouth. ANGELA didn't know what to do, her kids were in the hall.

JOEL threatened ANGELA, with a three some, if she doesn't do everything he wants, he is going to bring a girl home, tie up ANGELA and let her watch him fuck the girl. If she doesn't let him do what he wants he punches her. I asked her if he has punched her before, ANGELA said yes. I asked how many times, she said, he was punched her "a way lot" JOEL threatened to take HALE, if she didn't comply with his sexual acts.

JOEL made her open her mouth while he peed in it, he made her swallow. JOEL threatened her and said, someone told him something about her, he thought was true. She told him, she didn't know what he was talking about. JOEL made her prove it by, swallowing his pee. JOEL put his dick in her mouth, peed and made her swallow all of it.

While ANGELA was out of work after the Cadillac domestic assault, JOEL tortured her sexually. He stuck his hand up her butt hole. JOEL shoved his whole hand up her ass, and pushed up real high, ANGELA started screaming and JOEL said, "Oh you like that". ANGELA was sleeping and he kept waking her up and was doing shit to her. She woke up and he was jacking off, he came on her face. She went to wipe it off and he told her, don't touch it or I'll fucking break your neck.

JOEL used one of the kids, fisher price toys, that you put rings on, and shoved it up her ass.

On 02/23/06 about 10:15AM, I interviewed ANGELA concerning the specific assaults/events she could remember. The interview was conducted in the State Police interview room and was tape recorded. The following is a summary of the interview;

Angela stated the sexual assaults began after they returned from Cadillac, where she was severely beaten by him, MSP Cadillac complaint 76-1644-05 on June 25, 2005. Prior to that date he just physically beat her on a regular basis. ANGIE said the specific dates and times are hard to remember, they all blend together. All these acts have been continually since he got back from Florida in December. Ever since he came back from Florida, JOEL never wanted to fuck her in the vagina; it was either a blow job or her ass the entire time.

ANGIE said it's hard, because she has to act normal, because if JOEL finds out that she's saying things at work or if she's acting all depressed at work, he's going to find out and ANGIE will pay. I asked her what JOEL means, ANGIE said to her if meant another Cadillac, getting stomped and the shit beat out of her.

ANGIE stated she wasn't exactly sure of the date but it was around the end of June, July, when JOEL drove back from Cadillac, with her, HALE and ALAINA, she was all beat up. ANGIE walked in the trailer at 3266 Brutus Rd and went in to the bathroom, she was on the toilet when JOEL walked in the door. JOEL told her he wanted her to suck his dick, ANGIE started crying, because her mouth was all split open from where he punched her, she told him No I couldn't do it, JOEL punched her in the head, forced his dick into her mouth and came in her mouth.

The next day, ANGIE was on the couch in the living room, sleeping. She couldn't hardly move, ANGIE said she was on the couch for about 3 days, she felt like the wind was knocked out of her and she couldn't hardly move. He came over to the couch and told her to turn over, ANGIE told him she didn't want to, he said turn

over, she turned over, ANGIE was wearing PJ bottoms, he pulled them down and stuck what he said was three fingers up her ass hole, he shoved them in as far he could. ANGIE was screaming and crying, he kept saying to her, you like that, you like that. He started talking about some girl he was with and how she would do it for him if he asked her to. Then he stopped, she fell back asleep. ANGIE woke up to him standing over her, jacking off on her face. He came on my face, she went to wipe it off and he told her if you wipe it off I'll punch you in the face, she had to leave it there. She fell back asleep and then woke up and took a shower.

JOEL went to work, a couple of days after the Cadillac assault. JOEL made her go to her parents house. JOEL told her to tell them, the reason, I'm was coming there is because I was afraid to be alone, afraid the person who beat me up was going to come after me. ANGIE said, I was already kicked the hell out of and I didn't want to be kicked the hell out of any more. I already had a concussion and him hitting me in the head was scary. ANGIE was afraid JOEL was going to hit her more.

JOEL was working at Chestnut Valley Golf Course, when the Cadillac assault occurred. He took a couple of days off to stay home, telling them she was real beat up, needed somebody at home to work with the kids.

ANGIE said, JOEL left her alone for about a month and a half. JOEL started hitting her again. JOEL likes to punch ANGIE in the head, he makes a big fist and punches her repeatedly in the head, with his right arm. JOEL always says, "his right arm is his killer" He likes to choke her with his arm, bent at the elbow, laying on top of her on the floor in the living room or bedroom, she can't breathe or move. He forces his arm on top of her throat, where she can't breath or move. JOEL has threatened her more than once, saying he hated her and wanted to kill her. I asked her what prompts him to do these things, she said, who knows. ANGIE said Nothing ever prompts him, he doesn't like it, if you talk and he doesn't want you to, if you make comments to him about his beliefs, or the people he's talking to about his beliefs. You can't really prompt him, if you don't move fast enough, if your not perfect. If you're not satisfying what he wants enough, is what prompts him, there's no satisfying him, he's always prompted.

The sexual stuff started again while he was in Florida the end of December. JOEL returned from Florida on December 29, 2005 around midnight. Around Dec 26, he called her on the phone from his sister's house in Florida. JOEL told her to get on line on the computer, sign into Yahoo Messenger. ANGIE did and he started talking about how things needed to change in our relationship, that I wasn't no sexual dynamo. He wanted to have a three some, I tired to talk to him, why a three some, if I'm not making you happy, just tell me how I'm not and I'll work on it. JOEL told her if she loved him she would have a three some. I asked ANGIE, what happens if she didn't do it, she said, JOEL threatened her with not bringing HALE back. JOEL told her to get off line and call him. ANGIE did and when she spoke on the phone to him, JOEL told her to pick a girl. ANGIE told him she didn't have any friends and she didn't know anyone. JOEL said then you need to pick someone from work. ANGIE picked a girl from work named ALICIA, she didn't remember her last name. JOEL made me tell him exactly what I would do to her, about eating her out, her tits and just everything, I didn't want to and I told him that. He told her if she didn't then he would hang up and she would hear from him when she heard from him, HALE won't be coming back. He kept her on phone for along time.

He called from his sisters and told ANGIE to get on computer, and she did. He told ANGIE to set up web cam, She asked why, thinking he was going to send a picture of her for HALE. ANGIE set up the web cam. JOEL told her via computer to get a broom and shove the handle up her ass. ANGIE told him NO, it's disgusting,

I'm not doing it. JOEL told her, then you better find something. ANGIE told him there wasn't anything she could do that with. JOEL said to grab the toy that has the rings on it. The middle part that holds the rings will unscrew. JOEL said to use that. ANGIE said it was too big, she didn't want to do it. He said do it or we're ending this conversation and you won't see HALE. So she did it. JOEL made me do it on the camera, he kept saying, that's not far enough, shove it in further. Now, take it out and suck on it, put it back in, now finger yourself, he wouldn't let up. This went on for 1/2 -45 minutes, before he let her stop. ANGELA told him she had to go to her Mom's, JOEL told her not yet, get off line and call me. So she did. JOEL made her go over the three some thing again. I asked ANGIE how many times JOEL made her stick the fisher price toy inside her, she said maybe four times. Each time she took it out he told her to suck on it. I asked her if she did. ANGIE said, she had to you, he had the camera and I wanted my son back.

I asked ANGIE about the computer set up. She said the computer was set up in living room by window. The web cam is small and can be moved. ANGIE set the camera up on floor in the living room. ANGIE said she just wanted it to be over. ANGIE called on her phone to his sisters house, T & A [REDACTED] in Florida, number was 904- with the last four digits of [REDACTED]. After ANGIE complied with JOEL's wishes JOEL called her and told her they were flying in to Pellston. ANGIE's Dad took her to airport, so ANGIE could see HALE and bring him home. HALE and ANGIE went with her DAD and JOEL drove by himself. I asked ANGIE how she accessed the computer, JOEL instructed her to go in under Isabella, createrwoman, and the password she had to type was their phone number, 231 [REDACTED]. This allowed ANGIE into Yahoo! messenger. JOEL's name was dddufresne. Then they could talk/chat on line. ANGIE was only allowed to use the computer when he was at work and she could only use it to play her games.

They had just got home from the airport and JOEL was working on the computer, something happened and he was on the phone to a tech. He made ANGIE masturbate in front of him, he wanted her to finger herself, ANGIE told him she was on her period, he didn't care and wanted her to do it anyways. I did and when he wasn't looking I'd stop, then he would snap his fingers, point at her and give her the I'm going to kick your ass look. If ANGIE didn't do this he threatened to call ALICIA over for a three some.

JOEL got off phone with the tech, ANGIE was putting stuff away. JOEL said he wanted her to take a shower with him. They went back to the bathroom shower. They got in the shower and JOEL said, now turn around and bend over, ANGIE asked him why, JOEL said just do it, ANGIE bent over, and he shoved his dick in her ass, only left it in few minutes. JOEL told her to turn around. ANGIE did and JOEL told her, "to get on your knees and open your mouth" ANGIE was crying and told him, she didn't want to, he said do it or I'll call ALICIA over, so ANGIE did it. He made her suck his dick after he had it her ass until it was clean. I asked her if he came in her mouth, ANGIE said he didn't. JOEL just wanted her to clean it off. After she did this JOEL told her to stay down there, meaning on her knees. JOEL told her to open your mouth, stick your tongue out. ANGIE did and JOEL said, "if you move I'm going to punch you in the head and I'm going to make you drink it, his pee." ANGIE was crying, she told him it was disgusting, she didn't want to drink his pee, taste his pee, it was disgusting. Do or I'll leave right now, go to a bar, get a girl, bring her home, tie you up and let you watch me fuck her. ANGIE opened her mouth and he peed in it and ANGIE swallowed it. This type of activity continued until JOEL left on Valentines day. JOEL was constantly threatening her with a three some, taking HALE from her, or punching her in the head if she didn't comply with his forced sexual acts.

ANGIE said she would be sleeping, he would come in, wake her up and tell her to suck his dick, she told him, I'm sleeping, he would either slap her and tell me to suck it or I'll find someone to suck it and I'll bring her back home and you can watch, he threatened to take HALE and threatened to stomp her like in Cadillac. ANGIE said she knew if she didn't comply with his wishes, something would happen to her.

Things have been going on since he got back, ANGIE is lucky if she gets a one day break. I asked her what she meant by these things, she said, peeing in my mouth, cleaning his dick or fingers or what ever it he shoves up her ass. JOEL just wanted to see ANGIE suffer.

I asked ANGIE if he stuck anything besides his dick or fingers up her ass. ANGIE said he stuck a vibrator he bought up her ass. I asked her to tell me about that. ANGIE said it happened about three weeks prior to JOEL leaving on 02/14/06. It occurred at night, probably a Friday night, ANGIE had to open the next day and the kids were at Mom and Dad's. JOEL was on his computer, ANGIE cleaning the house. ANGIE went in the shower, and JOEL came in, He told her to stay in here, get on hands and knees, open your mouth, and he started peeing in her mouth. After he was done, she went to stand up, he said to suck it, suck the rest of the pee out. JOEL let her out of the shower. JOEL told her not to put any clothes on. JOEL came out took her into bedroom. He started to tie her up, ANGIE asked him what he was doing, JOEL told her he was going to tie her up and fuck her. ANGIE told him she didn't want to be tied up. JOEL said he would go get ALICIA and tie her up. ANGIE said JOEL was weird about the threesome thing, like he wanted to sexually torture. JOEL told her, this is what we're going to do. ANGIE said, you have to listen to him, you can do it the easy way, do what he says, keep you mouth shut or do it the hard way, disagree with him and then you get punched, thrown around, beat on until he decides your submissive enough so he can do this stuff. JOEL knew he had her with the three some thing, he knew she didn't want to have a three some. JOEL tied her hands to rails of HALE's crib, in their bedroom, she thinks he used his socks. She was on her stomach. He put a blind fold over her face, she thinks he used a receiving blanket. ANGIE couldn't see but she knows he had the vibrator because it was on. JOEL stuck the vibrator in her ass, took out the vibrator, told her to turn her your head and stick your tongue out. When ANGIE opened her mouth to say why, he shoved the vibrator in her mouth and told her now clean it off, it made her gag. He kept it in her mouth until she cleaned it off. He also stuck just one finger in her ass, digging with his finger nail, scraping it inside her, making her bleed, it bled for a couple of days. JOEL finished by fucking her in the ass with his dick, until he came. He untied her and that was it. He said that wasn't so bad was it. JOEL said I know you were scared and she said to him, Yea I was scared.

I asked her what other things has JOEL stuck up her ass. ANGIE said that toy, (Fisher Price ring toy), ANGIE said she threw it away after the second time he used it on her, and she told him she didn't know where it was. JOEL just sticks it in her ass as far as he can get it in there. JOEL sticks it in, pulls it out and continues this until he's satisfied it's been enough. The first time occurred during the first week of January. JOEL was using the computer, ANGIE was watching TV, he turned around and said come on. JOEL asked ANGIE where the toy was, ANGIE told him she didn't know (which was a lie). JOEL called her a "lying bitch" and said, tell me where it is. ANGIE told him, she hid it under a bunch of clothes in the closet. JOEL found it and got it out. ANGIE asked him what are you going to do with it, JOEL told her to turn over, ANGIE told him, "No, I don't want to it hurts really bad" JOEL threatened to hit her in the head with the infant see and say toy if she didn't turn over. JOEL made her take her pants off. ANGIE said she was crying, JOEL told her to lean over the bed with your feet on the floor. She did and he shoved the toy up her ass, took it out and shoved it in back in. ANGIE said it seemed like forever. She was crying and he told her to shut up she'll wake the kids up. When he

was finished he threw it back in the closet. I asked ANGIE if she was injured, she said, she was bleeding, but not gushing blood. The next time it happened was about a week later in the bathroom. ANGIE was going to the bathroom. She saw JOEL walk by down the hall towards the bedroom. He came into the bathroom, shut the door and latched it. ANGIE said the bathroom door didn't have a knob, but you could push the latch and secure the door. JOEL does this so ANGIE can't get out fast. The kids weren't home. JOEL told her to get up, she told him she was going to the bathroom, he said hurry and finish. JOEL had the toy, he told her to bend over the tub and he shoved the toy up her ass as far as he could, ANGIE was crying. When he pulled it out, ANGIE saw streaks of pink on the yellow toy. JOEL then shoved his dick in her ass and fucked her until he came and then made her clean his dick off with her mouth. JOEL left the room and left the toy on the bathroom floor. ANGIE picked up the toy and stuffed it behind the piping in the vanity. On her next day off, which could have been a Monday or Tuesday, she was cleaning house, got the toy from behind the piping in the vanity and threw it out in the garbage.

ANGIE said JOEL just comes out with the toy, he does it out of nowhere. She tells him, no not again, just let it alone, if you want to fuck me just fuck me, why do you have to do this. JOEL will say just shut up, keep her mouth shut and quit complaining and be happy you're with me. ANGIE got to the point you can't put up a fight, if you put up a fight, you'll get beat up and then he is still going to do it anyways, either way JOEL gets what he wants. ANGIE doesn't let him, she tells him she doesn't want him to do this, he knows I don't want him to and he knows that it hurts, but he doesn't care. I asked how he knows it hurts, ANGIE said, it makes me cry and bleed and just looking at the thing you know it hurts. 8" tall with 5 different colored rings on it, that get smaller as you approach the top.

JOEL fucked her in the ass for a week straight, every time he got horny. Her rectum was swollen, it hurt constantly, she couldn't hold things in. ANGIE kept feeling like she was going to crap her pants. One day getting ready for work, she did crap her pants and she told JOEL He just laughed.

JOEL stuck his dick in her mouth testing your gag reflex while the kids were running around in the trailer. This occurred about 1 ½ weeks before he left for Florida in February. ANGELA was in the shower and JOEL came in. He told ANGELA, she needed to get rid of her gag reflex and he was going to teach her how. He wasn't just getting a blow job, going in and out. He shoved in the back of her throat, telling her he wanted to feel her lips on his balls and on his stomach. ANGELA was gagging, she tried to pull her head away. He had her on her knees with her head held against the shower. He punched her and told her to keep her mouth shut. The kids are right outside this door playing. He didn't care if she puked. If she took her mouth off his dick she was going to regret it, he reminded her those kids are right out there, she didn't know if he meant hurting them or just kick the shit out of her in there. She tried not to move, but she couldn't breath, she started to pass out and he took it out and said, said there, now you give me a blow job like you mean it. If she didn't go far enough, he shoved his dick back down her throat, until he came in her mouth.

I asked about other times where things happened, ANGIE said she got the flue while working. This occurred during the time period ROB was staying at the house, two weeks prior to JOEL leaving. Her Mom came and picked her up and brought her home, she thinks it was a Wednesday because she had to call in sick for Thursday. JOEL came in and made her give him a blow job until he came. She told him no, I have the flu, its going make me puke, JOEL told her I don't care, puke during it I don't care your doing it. She complied. ANGELA fell asleep, JOEL came back in and whipped it out, ANGELA again told him, No JOEL please I'm

sick. He said, you don't have to do till I come this time, just suck it. I'd suck until he decided he was done. This occurred at least 6 times while she was sick. JOEL went to work this night, Wednesday, last time he worked. He called in sick the next day and got a note from the doctors at Quick Care.

On Thursday, ANGIE was in bed sleeping until 5PM in the afternoon, JOEL came in and decided he wanted to fuck her in the ass. She told him no, she has the flu, she has diarrhea, it's not a good idea, JOEL said, shut up quit arguing and he stuck his dick in her ass and he got all pissed off because he ended up with shit all over his dick. JOEL punched her in the head a few times and told her she was a sick bitch. He left her alone after this.

I asked ANGIE about other sexual things JOEL did after he came back from Florida. She said the only other thing she remember was him tying her neck to the chair, so he could do what he wanted without her moving her head. ANGIE said this occurred after the time in the shower where he tested her gag reflex. It was probably on weekend, because she had to work the next day and fellow employee ALICIA GOOD noticed pinched marks on her neck and made a comment. I asked her to describe what happened. ANGIE said JOEL told her he was going to finish off her gag reflex. It happened in the bedroom, Angie was dressed, don't remember how. ANGIE started crying and begged him not to. JOEL brought back a old kitchen chair, took a receiving blanket, spun it diagonally and tied her neck to the chair. ANGIE had to slouch down, so he could put his dick in her mouth. He shoved it in and out until he came. I asked how tight the blanket was tied. ANGIE said it was not tight enough to make me choke to death but tight enough to leave marks. She felt like she was being choked. JOEL untied her and that was it. I asked her about her hands, could she push him away, ANGIE's response was, "Not a good idea" I would have got punched, ANGIE said she just held on to the sides of the chair until he was done. ANGIE went to work the next day.

### INJURIES:

Possible internal injures inside the rectum, when JOEL shoved the toy, his dick and the vibrator up inside her. ANGIE was bleeding when these things occurred. Marks on her neck when he tied her up testing her gag reflex.

## TAPE RECORDED CONVERSATION BETWEEN ANGELA AND JOEL ON 02/22/06:

On Monday 02/20/06, I set up a tape recorder with recording attachment to the W[REDACTED] phone # 231 [REDACTED], at [REDACTED] Brutus Rd, so phone calls could be recorded between ANGELA, her family and JOEL. I instructed ANGELA and her father FRED on how to use the recorder. They were also requested to make a journal of the calls they suspected were coming from JOEL and #'s involved, from information off the caller ID.

On 02/22/06 about 7:24PM, ANGELA recorded a conversation between her and JOEL where he admits he is sorry for a number of the things she has disclosed. Tape to be transcribed and attached to report.

Prior to the call, FRED W[REDACTED] called JOEL at his sisters, 904-[REDACTED] advising him that ANGIE had calmed down and would now speak to him if he wanted to call back a little later, she would be home in about a half hour. About 7:24PM JOEL called, ANGIE recorded the conversation. During the conversation, side A stopped, ANGIE, put the phone down, wrapped it in a table cloth, turned the tape on side B and pressed the record/play button. She advised JOEL she needed to get a lighter and the conversation continued. Side B ended before the conversation concluded. As soon as the tape stopped, ANGIE told JOEL she would digest what he said, clear her mind and he could call back tomorrow morning and we could figure something out. ANGIE never spoke to JOEL after this.

## BRIEF SUMMARY OF TRANSCRIPT:

JOEL admitted the last month he's made ANGIE's life hell.

Since JOEL's got back from Florida, he's been an evil sick bastard

JOEL said he went from being mean to being an evil sick bastard

JOEL said he was sorry for all the sick mean shit he's done, for putting her through a living fucking hell, for not letting her live the Cadillac shit down.

JOEL said he was sorry for a the threesome thing and for making ANGIE describe it in detail for hours. He's sorry for using the fucking tool to fucking control her.

JOEL is sorry for asking her to suck his dick after he hit her in the ass

JOEL is sorry for testing her gag reflex

JOEL is sorry about his pee and for asking her to fucking swallow it

JOEL said it wasn't helpful when he tied up her neck to something to make her gag reflex go away.

JOEL admits he beat the holy fuck out of ANGIE in Cadillac.

After Cadillac JOEL admits he shoved three fingers up ANGIE's ass.

JOEL said he was sorry for making ANGIE do all kind of sick shit on the web cam for him, JOEL admitted he make her shove a toy up her ass. Since Cadillac JOEL said he's been a sick fuck.
