INTERVIEW KERBERSKEY:

On 03/27/06 at approximately 11:00AM I went to the Chapel Hill subdivision located off of River road where located Leon Kerberskey who was working construction on one of the houses.

I told Kerberskey that I wanted to talk with him about his relationship that he had with Angela W [REDACTED] Kerberskey agreed to talk. I asked Kerberskey to tell me about Angela and his relationship with her.

Kerberskey stated that Angela is psychotic. Kerberskey stated that she would hit him and beat on him when she got angry. Kerberskey stated that their friends would tell me the same thing.

I asked Kerberskey if they got along with each other. Kerberskey stated that they did not get along very well at all. Kerberskey said that they were never married. Their relationship lasted two years. He said they have one child together named Alaina. Kerberskey stated that he does not have visitation as the friend of the court wants him to take parenting classes.

Kerberskey said he has not had contact with Angela in the last 4 or 5 years as she got a PPO on him when they broke up. Kerberskey said that they broke up when a person named "Dan" last name unknown was arrested by SANE. Kerberskey said that Angela accused him of calling SANE and having Dan busted.

Kerberskey said that "if Angela got beat by her boyfriend she probably deserved it", "he probably could not take it any more". Kerberskey said he never beat Angela but did have to push her away.

I asked Kerberskey if she ever accused him of rape or threatened him that she would tell the police that he raped her. Kerberskey said she never did anything like that. Kerberskey said that Angela told him that she had been raped by her previous boyfriend. He said he did not know his name.

I asked Kerberskey if knew Joel Dufresne. Kerberskey said he did not know him nor has he ever met him.

As Kerberskey was leaving the patrol car he stated "whatever Joel says about Angela he would have to agree with him as he knows Angela".
